

# The Governing Body

## Brookland Church of England Primary School

The governing body of Brookland Church of England Primary School reconstituted on 24 March 2022 in line with the School Governance (Constitution) (England) Regulations 2012. Ten governors are appointed to sit on the school's governing body. They are responsible for setting the strategic direction of the school, ensuring financial health, probity and value for money, and holding the Headteacher to account for the educational performance of the school. The governing body review their structure, terms of reference and standing orders on an annual basis, and have adopted the '2 teams' model of governance. This requires the Learning & Development Committee, and Resources Committee to carry out regular monitoring, and report back to the full governing body.
